FIRST ORDER OF BUSINESS

Call to Order

Mr. Fischer called the meeting to order and read roll call confirming a quorum for the meeting.

SECOND ORDER OF BUSINESS

Audience Comments on Agenda Items

There were no members of the general audience in attendance.

THIRD ORDER OF BUSINESS

Consideration of the Minutes of the Board of Supervisors' Meeting Held on March 1, 2016

On a Motion by Mr. Porter, seconded by Mr. Chandler, with all in favor, the Board of Supervisors approved the minutes from the Board of Supervisor's meeting held March 1, 2016 for Wiregrass Community Development District.

FOURTH ORDER OF BUSINESS

Consideration of Operation and Maintenance Expenditures for February 2016

On a Motion by Mr. Gramling, seconded by Mr. Porter, with all in favor, the Board of Supervisors approved the Operation and Maintenance Expenditures for February (\$11,019.98) for Wiregrass Community Development District.

FIFTH ORDER OF BUSINESS

Consideration of Bid Award for Wiregrass Ranch Boulevard Phase 2, Phase 3, and Phase 4 Mass Grading Project

Mr. Fischer stated that the RFP Committee met prior to the Board meeting to review and rank the proposals for the Wiregrass Ranch Boulevard Phase 2, Phase 3, and Phase 4 Mass Grading Project and RIPA and Associates was the highest ranked responsive and responsible proposer. The Board indicated its desire to accept the recommendation of the Committee to award the contract to RIPA and Associates with a not-to-exceed amount of \$7,399,997.30. The following Board action was taken:

On a Motion by Mr. Porter, seconded by Ms. Miller, with all in favor, the Board of Supervisors approved Resolution 2016-08, awarding the contract for the Wiregrass Ranch Boulevard Phase 2, Phase 3, and Phase 4 Mass Grading Project to RIPA and Associates, LLC with a not-to-exceed amount of \$7,399,997.30, and authorized the Chairman and District Engineer to negotiate any scope reductions that may be appropriate due to fiscal constraints for Wiregrass Community Development District.

SIXTH ORDER OF BUSINESS

Consideration of Bond Related Matters

Ms. Whelan reminded the Board of the terms approved by the Board in the Bond Delegation Resolution and Mr. Cox reviewed the process of pricing and selling the bonds in the amount of \$9,430,000. He stated that there was a lot of interest in the bonds and they were able to attain an interest rate of just under 5%. It was stated that a pre-closing on the bonds would be conducted following the Board meeting.

Ms. Whelan reviewed the Supplemental Assessment Resolution, explaining that it essentially approves the terms of the bond issuance, confirms the provision of the Assessment Area 2 infrastructure improvements by adopting the Supplemental Assessment Area 2 Engineer's Report, adopts the Final Assessment Area 2 Supplemental Assessment Allocation Report and authorizes the collection of special assessments to secure the Series 2016 bonds.

Mr. Brizendine summarized the Final Assessment Area 2 Supplemental Assessment Allocation Report, highlighting the assessments levels by product type.

On a Motion by Mr. Porter, seconded by Mr. Chandler, with all in favor, the Board of Supervisors approved Resolution 2016-09, the Supplemental Assessment Resolution for Wiregrass Community Development District.

Mr. Johnson informed the Board that the District does not have an Investment Banking Agreement in place authorizing MBS Capital Markets to facilitate the sale of the Series 2016 bonds on the District's behalf and setting the compensatory fee. He explained that from a regulatory standpoint this should have been executed in the early stages of the discussions and should be made retroactive to that time.

On a Motion by Mr. Chandler, seconded by Ms. Miller, with all in favor, the Board of Supervisors approved the Investment Banking Agreement with MBS Capital Markets, retroactive to the date of commencement of the issuance of the Series 2016Bonds, for Wiregrass Community Development District.

SEVENTH ORDER OF BUSINESS

Consideration of Construction Related Business

There were no construction matters put forward at this time.

EIGHTH ORDER OF BUSINESS

Staff Reports

A. District Counsel

Ms. Whelan touched briefly on the legislative session that just ended, stating that a report would be provided next month.

A brief discussion was held regarding the District's desire to amend the boundaries of the District. At the Board's direction, District staff will commence preparing the necessary documentation to accomplish this.

B. District Engineer

Mr. Sheridan stated that he has been working with Withlachoocee River Electric on the electrical service for the Hueland Pond Project and there will be some additional costs associated with it. He stated that he would have a report to present to the Board next month.

Mr. Fischer reminded the Board that the next regular meeting will be held on April 27, 2016 at 10:00 a.m. He recommended that the 9:00 workshop be used for preliminary discussion of the fiscal year 2016/2017 budget.
